## Your Cost in Obtaining Needed Legal Services

That is, we usually agree to wait until our client's case is either settled or completed at a trial before we get paid. In appropriate circumstances, we agree to pay the expenses needed to move the case through the Court process (such as expenses for doctors that will testify in the client's case or expenses related to filing documents with the Court). We meet with our clients personally to discuss a contingency fee arrangement and we will put our agreement in writing so that our clients will have a thorough, written description of the legal costs they can expect to incur in seeking compensation from the person or business that hurt them.

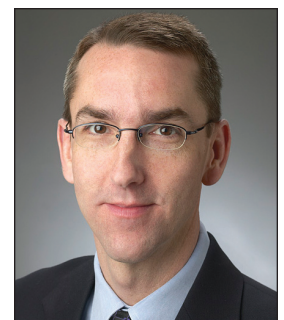
